

THE IMPACT OF SEXUAL VIOLENCE IN THE MEDIA ON MANDAILING NATAL WOMEN

Abstract

The substance of the news while interpreting the incidents of sexual violence through news content should fulfill the journalistic code of ethics. News of sexual violence in particular, is a news subject that commonly emerges on online media in Mandailing Natal Regency. This research adopts a qualitative method through content analysis of sexual violence news on online media in the Mandailing Natal. The results of this study reveal that the news information released by online media regarding sexual violence has met the norms of journalistic regulations and the journalistic code of ethics. The news also masked the identities of victims of sexual violence. In addition, there were inadequacies in the news material in the form of typos and mixing of facts and opinions. Victims who view news broadcasts of sexual violence are known to have emotional consequences in the form of behavioral and cognitive issues that lead to psychological pressure on victims.

Abstrak

Substansi pemberitaan dalam memaknai peristiwa kekerasan seksual melalui isi berita selayaknya memenuhi kode etik jurnalistik. Berita kekerasan seksual khususnya, menjadi topik pemberitaan yang sering muncul pada media online di Kabupaten Mandailing Natal. Penelitian ini menggunakan metode kualitatif melalui analisis isi tentang berita kekerasan seksual pada media online di Mandailing Natal. Hasil penelitian ini bahwa konten berita yang dipublikasikan oleh media online tentang kekerasan seksual sudah memenuhi standar kaidah jurnalistik dan kode etik jurnalistik. Berita tersebut juga menyamarkan identitas korban kekerasan seksual. Terdapat kekurangan isi berita berupa salah pengetikan dan pencampuran antara fakta dan opini. Korban yang menyaksikan tampilan berita kekerasan seksual diketahui memiliki dampak emosional berupa gangguan perilaku dan kognitif yang berujung pada tekanan psikologis korban.

A. INTRODUCTION

The way sexual violence is framed in news reports gives certain information to its readers. Often, the news influences its readers to follow the flow of events reported by journalists to completely inform them of the chronology of events, the moment of the incident, and the impact made by the incident. This research was undertaken because it requires a bright spot between the information supplied by journalists and the impact on women in Mandailing Natal.

Mandailing Natal Regency is one of the districts in North Sumatra Province where sexual violence charges are extremely high in the news. This is the major strength of this research: that it is interesting to explore and take up the object of research on the media in Mandailing Natal so that the findings of this research can be valuable for future media researchers. Media relations and power that present the story of sexual violence in depth and are armed with news images to corroborate the story undoubtedly have a purpose and reason for covering the news. The news supplied adds a touch of new value to readers who are aware of the sentence structure and source quotes included in the news material.

The impact of sexual violence on victims is so profound, such as the pain that comes upon remembering the experience. Whether we recognize it or not, Mandailing Natal Regency needs to establish a mature plan to limit the frequency of occurrences of sexual violence and ensure proper management. The media that have massively reported on sexual violence in Mandailing Natal can be found in the following table:

From multiple lists of violence news in the Mandailing Natal district media that frame sexual violence from various sides and views, it can be determined that cases of sexual violence that are included in news publications turn out to be the main highlight for readers. In this research study, we solely focus on three news items that prioritize reporting incidences of sexual violence in detail and in depth.

Sexual violence news should employ initials or pseudonyms without mentioning the real identity or photo of the kid victim or perpetrator. However, there are certain news items that mention the victim's address so that readers who know the address can trace it, or even readers themselves can trace the victim's identity.

B. LITERATURE REVIEW

Research conducted by Safira Suhra in 2019 with the title "Kekerasan Perempuan dan Anak Dalam Media Dan Upaya Penanggulangannya".¹ The main problem in this study is violence against women and children in the media and efforts to overcome it. The author employs a sociological approach to solving the problems in this writing. The method used in this research is the descriptive analysis method. The data for this research is divided into two categories: primary data and secondary data. The results show that women and children are most vulnerable to violence, physical or psychological abuse, exploitation, persecution, and becoming victims of human trafficking, including victims in the news media and advertisements. Efforts to prevent violence in the media should focus on the perpetrators and victims of violence themselves, providing them with advice and psychological and medical therapy to avoid individual violence, as well as attempting to eliminate violence for victims by reducing the frequency of watching television that broadcasts violence and sensual advertisements that appear to exploit women, not believing one-sided news published by newspapers, and enforcing legal sanctions against perpetrators and victims of violence.

Furthermore, research from Rissa Indrasty et al. (2018) on "Gender dalam Kasus Kekerasan terhadap Perempuan di Media Online".² This paper explains what happens to women in cases of violence against women displayed by the online media site Pojoksulsel.com, where women are often made the guilty party in cases of violence against them. The research will look at how the position of the female subject-object is displayed in the text, how the position of the author-reader is displayed in the news text, and how the depiction of forms of violence against women is displayed in the news text. The research method uses a descriptive method with a qualitative approach in the tradition of discourse analysis. The results showed that the position of women in the news discourse at Pojoksulsel.com is as the object of the news, while the subject of the news is the editor of Pojoksulsel.com and the police. The position of the writer, or Pojoksulsel.com, is more dominant in the text, while the position of the reader is passive. With limited text, the reader is directed to accept the stereotypes given by Pojoksulsel.com, which directs the reader to blame women for the misfortune that befalls them. The forms of violence against women displayed by Pojoksulsel.com are very detailed and sadistic, with women

described as physically, sexually, and psychologically abused. It can be concluded that there is a gender imbalance in the news.

The commonality in this research is that it focuses on sexual violence, which is described in the news and has a big impact on women. The difference between the above research and the topic researched is that the news of sexual violence, whether it is in conformity with journalistic norms and codes or if it has an influence on women, is studied in depth to find out the psychological impact on victims of sexual violence. This impact can be determined through data sources obtained from interviews and by presenting the consequences of media coverage.

C. RESEARCH METHOD

This research study employs a qualitative content analysis method, which tends to describe media content as seen through the context and process of source documents, resulting in more in-depth and detailed results about media content that can explain the relationship that occurs between media content and the context of social reality. In terms of researching content analysis, researchers focus on three news items published differently in three Mandailing Natal media with the same issue of discussion, namely sexual violence. The three news and media outlets are as follows:

The way journalists examine instances by presenting a point of view and coloring their writing with critical and harsh writing to arouse curiosity in readers to be explored more extensively is why researchers chose the topic of the three news items above. After the news is picked, the researcher will study

the content of the news and discuss paragraph by paragraph to uncover content that is not in agreement with the rules or journalistic code of ethics. from the news, followed by in-depth interviews with victims of sexual violence to find out the impact they felt when watching and remembering the events included in the news.

D. RESULT AND DISCUSSION

The keywords "sexual violence news" underlie journalists' desires to document events through online news pages and disseminate them to audiences who are interested in reading them. The relevance of sexual violence news will be described in detail in the three news choices above. The first news entitled "Madina Ranked First in North Sumatra for Sexual Violence Cases," published on July 23, 2019, has the following content:

Panyabungan, StArtNews - Mandailing Natal (Madina) is ranked first in North Sumatra in cases of sexual harassment, from figures from 2017 to this year, apart from the police there are 108 cases handled by the Madina PPPA Office consisting of cases of harassment and sexual abuse. This was said by the Head of the Protection of Women's and Children's Rights (PHP2KH) Efrida Nasution in her office Tuesday 23/07.

"The number of violence against children from year to year continues to increase, for that it will continue to conduct socialization from village to village so that awareness of children's rights can be understood by parents and residents," said Efrida to StArtNews.

She explained that children are the biggest investment as the next generation of the nation, especially in Madina, so they should not be easily influenced by the sophisticated technology that is growing rapidly today and expects parents to be more vigilant in supervising children's behavior.

The Mandailing Natal (Madina) Regency Government, said Efrida Nasution, through the Madina Women's Empowerment and Child Protection (PPPA) Office. continues to be committed to building child-friendly spaces. In this regard, it is hoped that awareness will be raised from all parties, including the community, parents, families and the world, to take a role in protecting children from socialization.

The Head of the Madina Women's Rights Protection and Child Special Protection Division (PHP2KH) also said that in accordance with the motto of National Children's Day (HAN) in 2019, "We are Indonesian children, we are happy."

HAN, which falls on July 23, is also expected to be a momentum for all parties to increase awareness of the fulfillment of children's rights and protection.

PPPA Madina also provides 24-hour service by establishing a complaint post through the Call Center by contacting the norms below 081361033691/081265685288.

From the news above, it can be concluded that the news writer prioritizes the level of sexual harassment over the past three years. The news writer also completes the news with clear information from the main source so that any victim who reads the news can immediately respond to request a complaint service. In the news writer's point of view, putting the position of victims of sexual harassment in an important place and must be helped so that follow-up is needed from the authorities in overcoming the incident. Technically writing news or news journalistic rules, startfmmdina.com journalists have explained with the 5W + 1H principle to answer in detail the level of sexual harassment in Mandailing Natal district.

The shortcomings in the writing of this news are typos such as "teknologi" should be "teknologi", "mengaharapkan" should be "mengharapkan" and the word "moto" should be "motto".

The second news was entitled, in Mandailing Natal, this Angkot Driver Impregnated a Junior High School Student which was published on November 08, 2021, the following is the news content:

PANYABUNGAN SELATAN, - TP (14), a junior high school student in Mandailing Natal Regency (Madina), was sexually assaulted by ML (33) who works as a public transportation driver.

Now, ML, a resident of Huta Raja village, Panyabungan Selatan sub-district, has been secured by the Madina Police criminal investigation unit personnel based on a report from the victim's parents. The perpetrator himself is known to have a wife

Information obtained by MohgaNews from the Head of the Criminal Investigation Unit, AKP Azuar Anas, Monday (11/8/2021), the perpetrator was secured on Thursday (11/4/2021) last week, based on LP/B/248/X/2021/SPKT/Polres Madina/Polda Sumut dated October 22, 2021.

"The perpetrator committed sexual violence against the victim by having intercourse with her until she became pregnant. The victim is three months pregnant, and the victim is currently a junior high school student," said Azuar.

According to the confession of the perpetrator, they committed this depraved act repeatedly.

"The perpetrator has admitted his actions, 10 times in different places. Starting last June,

"In July, 3 times, in August 4 times, in September 2 times and at a cafe that was left behind in Huta Raja Village, South Panyabungan once in October," said the Kasat, Monday (11/8/2021).

Azuar explained, based on the confession of the victim's parents, TP is currently 3 months pregnant.

"We have detained the perpetrator for further investigation. And, the victim is currently 3 months pregnant," he said. (MN-08)

In writing the news above, journalists have implemented the journalistic code of ethics, namely shielding the identities of the victim and perpetrator by using their initials only. Journalists have also explored in detail the chronology of sexual assault experienced by the victim so that readers realize the magnitude of the agony faced by victims of sexual violence as mentioned in the news. Journalists also write 5W+1H in the news idea with the perspective of the victim who wants the culprit to be given an appropriate penalty. Although the news seems brief, the content of the news is plain and information-dense, so that it is easy for readers to understand the condition of the writing.

The disadvantage of this news writing is the use of harsh phrases such as "sodomize", "depraved" and "pregnant".

The third news entitled Incest Rape in Mandailing Natal and Criminal Law Review was published on November 21, 2022. The following is the content of the news:

The advancement of science and technology that has occurred today has brought changes to the pattern of human behavior in society. Some of these behavior patterns lead to good and some lead to behavior that deviates from the norms that exist in society. We observe impressions in various mass media, providing information that presents cases of rape and sexual harassment. The crime of rape does not only occur with other people, it is often committed with fellow family members, neighbors and even between father and son.

As happened in Muara Batang Gadis District, Mandailing Natal Regency, North Sumatra. A child was raped by her stepfather with the initials AN against a 6-year-old child. The father had the heart to carry out his cruel actions repeatedly to the child, causing serious injuries to the child's vital organs.

The depraved actions committed by AN against his stepdaughter were carried out when his wife was not at home or was working as a laborer in the garden. AN also threatened the child not to tell anyone about the incident. However, as the saying goes "as smart as a carcass is covered, it smells too".

Quoted from lingkaran.id since this case was reported on Monday, November 21, 2022 the perpetrator has been arrested by the Mandailing Natal Police Criminal Investigation Unit. (iNewsMedan.id).

This case is not the first to occur in 2022 in Mandailing Natal District. Previously, on July 22, 2022, a man with the initials MJ from Sinunukan District raped his sister-in-law many times. MJ carried out the action when his wife was not at home. The depraved action was often repeated at night. This incident was revealed after the victim ran away from her brother's house and then contacted her parents in another district via telephone. Previously, the victim did not dare to complain to her brother because she was threatened to be killed by the perpetrator. As a result of his depraved actions, MJ is now detained at the Mandailing Natal Police Station. The perpetrator is charged with the Child Protection Law (UU) with a sentence of 15 years in prison. (Lensakini.com)

In the conception of criminal fiqh (al-Hudud), rape is classified as a crime against honor (hak al-'ardh), in the form of adultery with the threat of 100 lashes or stoning to death. Adultery is prohibited by religion as well as against the laws and customs of society. In addition, the impact is enormous, both for the perpetrator and for society. Under Islamic law, adultery is one of the major sins. The Qur'an prohibits us from approaching zina (rape), let alone committing it against one's own child is one of the crimes against humanity that destroys the order of family life, households and social life of the community. As explained in QS al-Isra': 32.

The prohibition of approaching adultery (rape), especially sexual harassment behavior against one's own family, including that committed by a father against his child, is called incest in psychology. Victims of incestuous behavior will experience very deep physical and psychological wounds. Psychological wounds that may be experienced include feeling very frightened, in pain, hating their father and possibly hating the adults around them. They may feel self-hatred because they feel confused and troubled, disappointed, angry and resentful. The result will be behavior that is not easily understood, withdrawal, resistance, violence, fear, impulsivity, sleep disturbances and can even have an impact on academic achievement which will be disrupted. If psychological disorders due to sexual violence or post sexual abuse trauma are not treated immediately, the more the child grows up, the more they will experience self turmoil where they feel low self-esteem, feel guilty, angry, alone and unwilling to socialize with others.

Some experts state that marriage for incest victims is not a solution. Victims who do not receive good treatment can become victims of continuing sexual violence, and can also become perpetrators of revenge.

From the cases of rape against children that occurred in Mandailing Natal Regency in particular and generally in Indonesia, it is considered as one indicator of the lack of quality of child protection, even though it is clear that religion has prohibited adultery, especially rape committed by parents due to the existence of weak faith, irresponsibility and poor family life conditions. Thus, the application of more severe legal sanctions is needed.

In Islam, the sanctions against the perpetrators of adultery/rape are very clear, but the application does not yet exist, because Indonesia has not enacted Islamic criminal law, so what happens is that the application of Islamic law is only limited to matters of worship while on the issue of criminal acts the application does not yet exist. In the application of sanctions based on positive law in Indonesia, sanctions for perpetrators of criminal acts of rape are still considered light, especially since the risks experienced by victims are very large. Therefore, it is necessary to review the laws and regulations that apply in Indonesia in general.

In principle, the news writer above mixes news writing with the author's opinion so that the information captured by readers becomes biased information. The news writer has not fully used the principles of journalistic rules and the 5W+1H method to explore cases of sexual violence even though the writer has hidden the identity of the perpetrator by mentioning initials only. The author's point of view refers to the criminal law review which gives the power of opinion for readers to understand more about the impact of sexual violence that occurs. In addition, there are still typos such as "tehnologi" should be "teknologi".

Psychological Impact of Sexual Violence News on Women

From some of the news descriptions above, researchers took the common thread that sexual violence against women will have an emotional impact on victims in the form of behavioral and cognitive disorders that lead to the victim's psychology. When the victim was interviewed in depth by the researcher, it was found that there was an emotional disturbance that made the victim unstable in behavior and experienced a bad mood when witnessing the news. When remembering the incident, there was a tendency for the victim's behavior to lead to negative things such as excessive laziness.

Furthermore, the cognitive impairment experienced by the victim due to the news affected the level of concentration that was difficult to achieve at the mindset level. This will make victims daydream more often and have empty thoughts or the like. The psychological impact experienced by victims of sexual violence is not as simple as the general public thinks. Basically, the erratic

mindset of victims of sexual violence affects their thoughts in a negative direction, even to the point of destroying themselves.

The researcher's findings during interviews with victims of sexual violence are that the impact experienced by victims takes many forms, ranging from their perspective, way of thinking about a condition, emotional stability and even depression. This causes post-trauma for victims. This trauma causes various things such as excessive anxiety and fear due to the brain repeating the incident through the victim's memory even though the flashback occurred accidentally.

E. CONCLUSION

The tendency of news writers from several news articles analyzed resulted in the following conclusions: 1. The sexual violence news contained has fulfilled the elements of good and correct journalistic rules, it can be seen from the writing that covers the identity of the perpetrators and victims of sexual violence. 2. The journalist's point of view that prioritizes the quality of the news content on two sides can be seen that the author supports the victim to get protection, besides that the information is written that the perpetrator gets a sentence equal to his actions. 3. There are still shortcomings in the news content such as typing errors and mixing facts and opinions of the author.

Victims who witness news displays of sexual violence are known to have emotional impacts in the form of behavioral and cognitive disorders that lead to psychological pressure on victims. The disturbance from the news display also takes various forms on the victim, ranging from the perspective, the way of thinking about a condition, emotional stability and even depression. This causes post-incident trauma for victims. This trauma causes various things such as excessive anxiety and fear due to the brain repeating the incident through the victim's memory even though the flashback occurred accidentally.
